Covid-19 Update

UPDATE The City Building is now going to be CLOSED to the public until at least May 11th in coordination with the Governors first steps in reopening the economy. The City is working on an action plan with the Kentucky League of Cities that will help set a course of action as the State, Region and City, take steps to reopening the economy. Ervin Terrace Construction

The Sanitation District #1 is making good progress on Ervin Terrace. They are in the final stages of their work and we expect them to wrap up by next week, pending no other surprises. Afterwards the paving company will be in to finish the blacktop work. Project is on pace to be completed this Spring.

Development

- **Manhattan Harbour - Update**

Brendan Sullivan closed with Mark Stark and Dave Imboden on The Bend Property, otherwise known as the Narrows (east of Berry Street), last Friday. We are hopeful that construction will begin soon on this site along with two other sites in the Commons section of Manhattan Harbour.

Special Projects

- **Riverfront Commons – No Change**

60% Design submitted to KYTC for approval. Project is on schedule to bid out construction this year.

- **Sidewalk Improvement Project - Update**

Right-of-Way documents have been sent to KYTC for approval. Project is on schedule to bid out construction this year.

- **New City Building – No Change**

Nothing new to report.

Other

The dirt has piled up again on Route 8 from the trucks. We are in the process of scheduling a street cleaning for sometime next week and will post no parking in advance.

The next regional Storm Water meeting that was scheduled for May 5th has been pushed to July while cities cope with the ongoing pandemic.
