

Economic Development Report:

We accelerated the payment of CCAP Rental Abatement Checks from around the 15th of the month, to the start of the month.

We've developed a table of businesses offering carry-out and delivery that has been distributed via social media, the City's Web site, and the new eNewsletter.

Set-up, developed an eNewsletter for the City of Dayton. Pulled email addressees from iWorks it went out to about 300 email addresses, and over 50 people have signed up through the Web site. Also distributed the eNewsletter via Social Media.
